Call to Order

- FCS PTO meeting was called to order at approximately 7:04pm by Lydia Parris, PTO President, virtually (zoom) on March7, 2023
- > Opening prayer led by Lydia Parris, PTO President
- Mrs. Parris noted that our April meeting will move to April 11th at 7pm since the previous meeting date is during spring break

PTO Funding Requests

- The PTO board presented the funding request form for teachers/staff, which will launch this spring 2023
- Mrs. Vislay & Mr. Lawrence have approved the funding request protocol & form
- The purpose of the funding request form is as follows: to allow teachers/staff to request special funding to support the staff/student body to further its mission to support the education of students at FCS & its teachers/staff by fostering relationships and building community
- PTO request items include special items not already covered by the Forcey Christian school budget; subscriptions will be excluded, for instance, if already covered by the school budget
- The PTO funding requests will be voted on by the PTO board/members twice yearly, at November and May general meetings; majority requests will be granted (rank-choice voting system)
- The funding request limit (as of this school year): \$800
- Information sheets will be sent to all FCS staff members

Nomination Process

- Per Ginny Lee, Membership & Nominating Chairperson, the nomination process will be extended since there were not many nominations the past few weeks
- Mrs. Lee requested that current board members describe their role on the board
- Mrs. Parris reported that the Presidency role entails the following: utilizing leadership/administration skills, delegating responsibility among board members & committee chair leads, keeping track of all activities through the PTO & providing advice/support as needed, shepherding emerging leaders; the Vice Presidency role entails: support of the President/board & committees, developing policy & overseeing special projects (room parent program, etc.)
- Per Mrs. Lecy-Alvarado, the Secretary position entails: writing meeting minutes for leadership, board, & general meetings; record keeping of minutes & policies/forms, support the board; the Treasury role entails: keeping track of expenses and deposits, monthly budget reports, financial accountability, develop/streamline policies/funds, assist in developing the annual budget
- All PTO members are encouraged to nominate themselves or others who may qualify for either position
- The PTO board wishes to utilize the gifts & talents of all eligible parents who wish to join the team
- It is noted that the committees do the majority of the work for the PTO & the board member does not need to join or participate in a committee while on the board, unless it is desired; it is preferred that the PTO board member does not lead a committee while on the board
- New PTO board members for the 2023-2024 school year will be sworn in at the next PTO meeting, after voting is adjourned

Membership & Nominating Committee

- The PTO mixer is scheduled for Friday, March 10th at 3:10pm in room 150
- The purpose of the mixer is to mingle with current & prospective PTO members for fellowship & to give out information about the PTO
- All FCS members are welcome, & it is encouraged to bring your children

- > Erin Crowley, chairperson, reported that the electronic staff greeting cards continue
- Ms. Crowley is requested that she be notified of life changing events in order to send a card, such as weddings or other personal moments
- The SEC committee will supply St. Patrick's Day goody bags to staff on March 17th & all funds for the bags are provided from the PTO budget
- > Another drink cart visit to FCS staff will be scheduled the week after spring break

- Martha Arteaga, chairperson, reported that the committee sold four (4) ad pages in the yearbook; if any other businesses would like to participate, please contact the PTO directly to request
- If the committee is unable to sell the last two (2) pages, then those pages will be given back to the yearbook for usage or used for PTO pages

Events Committee

- Mel Masta, chairperson, reported that he and Mrs. Arteaga are in contact with Mr. Lawrence about how the PTO can support the upcoming FCS Gala on April 28th
- Mr. Masta thanked Mrs. Palmer for her school support as a police officer in protecting the students and families this year; most recently she assisted with traffic safety with the tree removal event on campus

Volunteer Updates

- Per Mrs. Brigner, PTO parent/library aide, the library is still in need to volunteers to rearrange fiction/non-fiction books in its proper location, & taping 3-4 more boxes of newly purchased library books
- A used book sale will be scheduled this spring; FCS families are encouraged to donate gently used books for the sale

- It was asked whether the spring fling was the same as the spring gala: the spring fling is a PTO sponsored community event with fundraising for the PTO; the spring gala is FCS's spring fundraiser for the school itself
- Spring Gala notes: the PK staff will not be assembling baskets, however, will volunteer to watch preschool aged children while the parents attend the gala; tables will sell for business advertisement; FCS children will participate in a show & dinner is provided to the children without cost; dinner for the gala is included in the price for the ticket & all are welcome (parents/children/other family)
