## Call to Order

## Leadership Vacancies for next year:

<u>UPDATE:</u> Jennifer, Ginny and Tanisha met after this general meeting to explore some options to help establish some leadership at SY 24/25 PTO meetings.

They have proposed 4 in-person meetings instead of the usual 12 via Zoom. Each meeting could include food for attendees and their children, a speaker who can speak on a topic of interest for the audience ie: mental health, how to help children with reading level improvement etc. and a 15 minute PTO business portion in the beginning so members can vote on things like the budget, teacher request etc.

The executive team may also choose to meet outside the general PTO meetings to get permissions for events etc.

This will be discussed further at our final executive board meeting of the year later this month.

## Finance Update:

Christina Buggappa (Treasurer) shared the following financial report:

Financial Report thru 04-2024

Christina shared that we raised over \$10,000 with Pizza Fridays and \$165 with the KONA Ice fundraiser. \$2000 has been projected for the second round of special teacher projects. Given that there is lots of surplus money projected for the end of the year, a suggestion was made to raise the teacher projects total funding amount to \$2500. A suggestion was also made to raise each limit request to \$500. We voted on both of these suggestions and they both passed.

#### **Fundraising Committee**

- Martha Arteaga, chairperson, reported that Pizza Friday is our biggest fundraiser of the year. Next year it will be offered every other week again. We can add more Fridays if we get more volunteers.
- The Used Uniform Sale will be held on Friday, May 31st after school with "dollar bottoms".
  It will be held outside, weather permitting. (If the weather is bad, it will be held in Room 150.) We need volunteers to help with bringing the uniforms outside and to help with the sale. The flyer just needs to be revised with the new date and the dollar bottom information. We will have another used uniform sale in the summer.
- Spring Fling is Saturday, June 8th and is a great event for the closure of the school year. We need PTO leadership at the PTO table. Mel is coordinating a scavenger hunt. Jennifer will recruit Room Parents to help with marketing and volunteering. We need 4-5 volunteers for the dunk tank. Karen is helping to recruit for this.
